Approaching New York

Consider these aspects:

- Complex history
- Time period—record types can vary by period
- Key resources and repositories

Learning about these aspects can help guide you to a pathway to successful research.

Understanding New York's History

Learning New York's history aids in research. New York has undergone many changes in government and ruling authorities.

- Current laws and municipal organization & jurisdictions
- Statehood
 - Late 1800s and early 1900s
 - 1780s/1790s and early 1800s
- Colonial English/British
- Colonial Dutch/New Netherland

A chronological snapshot of events that affect records may be found in the New York Family History Research Guide and Gazetteer (NYFHRGG), p. 1-6.

Factors influencing New York State's colonial predecessors

- Early European settlement
- Migration from New England
- Immigration from abroad
- Wars and conflicts
- Transportation explosion
 - Waterways
 - Turnpikes (plank roads, etc.)
 - Erie Canal 1817-1825, later enlargements and expanded canal system.
 - Railroads

New York Municipal Organization

Understanding of governmental organization also helps find records.

State

Counties

Towns (not townships)

Cities (subordinate to Towns, mostly)

Villages (incorporated)

Hamlets for Post Offices, school districts, water districts, etc.

Hamlets can be a larger population than towns or cities

Key records to find

- Birth, death, and marriage
 - 1880s-present look for civil vital records (earlier for some cities) New York State Health Department (NYSHD), except NYC
 - Statewide indexes
 - Copies at NYSHD and local towns and villages
- Pre-1880s civil vital records highly unlikely to exist—look for substitutes, including probate and religious records
- Probate (estate/wills) records from the Surrogate Court
- · Census, including state censuses
- Newspapers
- Religious records
- Land records
